## FALL MIZISE (TURKEY) HUNTING REGULATIONS - WISCONSIN

---

**NOTE:** The rules summarized in this handout are the minimum rules applicable to tribal members hunting mizise (turkeys) off-reservation. **YOUR TRIBE MAY HAVE IMPOSED ADDITIONAL RESTRICTIONS OR REQUIREMENTS.** Check with your conservation department to see a complete copy of your tribe's ordinance, or to see if additional regulations apply to your hunting activities. Note that special hunter education requirements and restrictions exist for hunters under age 16.

**PERMITS:** You must have a current off-reservation harvesting permit validated for small game hunting in order to hunt turkeys.

**HUNTING HOURS:** One-half hour before sunrise to 20 minutes after sunset.

**FALL SEASON DATES:** Day after Labor Day to December 31.

**TURKEY MANAGEMENT ZONES:** The map on the reverse side displays the turkey management zone boundaries, and the approximate ceded territories line. For zones that border the ceded territory, you may hunt the portion of these zones that are within the ceded territories.

**BAG LIMIT:** You may harvest no more than 3 wild turkeys per day. Birds of either sex may be harvested.

**CARCASS TAGS:** Carcass tags are not required to hunt turkeys in the Wisconsin ceded territory. However, all birds harvested must be registered (see below).


**REGISTRATION:** All turkeys harvested must be registered. You may do this by presenting the entire carcass to a GLIFWC warden or at a tribal registration station or no later than 5:00 p.m. of the third working day following the harvesting, or by phone by calling 844-234-5439. You are required to accurately provide all information (such as the age and/or sex of turkey, zone of harvest, etc.) requested at registration.

**METHODS:** No member shall hunt wild turkeys:

- a) By any means other than a shotgun or muzzle-loading shotgun fired from the shoulder, or a bow and arrow or a crossbow.

**METHODS (continued from the reverse):** No member shall hunt wild turkeys:

- b) With the aid of recorded bird calls or sounds or electrically amplified imitations of bird calls or sounds.
- c) With live decoys for the purpose of enticing wild turkeys.

**OTHER RESTRICTIONS:**

While hunting turkeys you must also comply with all other restrictions which apply to hunting generally, or to small game hunting specifically.
