Open-Water Hook and Line Regulations: Ceded Territory in Wisconsin

This summary of hook and line fishing regulations is based on the Model Off-Reservation Conservation Code of the Wisconsin bands of Lake Superior Chippewas. Your Tribal Council may enact regulations that are more restrictive than those summarized here. For more specific information, contact your Tribal Conservation Department or the Great Lakes Indian Fish and Wildlife Commission (GLIFWC) at 715-682-6619.

Open Water Fishing means all fishing other than fishing through an artificial hole in the ice.

Hook and Line means a rod and reel or similar device such as a hand held line, and includes trolling. No more than 6 lines with a maximum of two hooks or lures per line may be used.

Permits: No tribal member shall fish pursuant to this ordinance without possessing a valid fishing permit. Contact your Tribal Conservation Department.

Live Bait: The following species may not be used as live bait: carp, goldfish, redhorse, freshwater drum, burbot, bowfin, garfish, buffalo fish, lamprey, alewife, gizzard shad, smelt, goldeye, mooneye, carpsucker, quillback, or crayfish.

Possession Limit: The possession limit for hook and line caught fish is double the daily bag limit.

Fish Refuges: Tribal fish refuges generally parallel state fish refuges. State fish refuges are posted by the Wisconsin DNR. Check with your Tribal Conservation Department for more information.
